b) District Councillor Report

GN will follow up on any specific examples of small electrical waste not being collected. He advised that Broadland has pledged 0% increase on its portion of Council Tax next year. GN reminded Parish Council of the Warm Homes and Warm Spaces Grants. JC advised that the latter has been discussed by the Village Hall Committee. Broadland News will be delivered in December, with news of a phone app for checking Broadland services such as bin collection. GN was pleased to report that Broadland's recycling, at 50.6%, is the highest in the county. Parish Council discussed the impact of Norfolk County Council's budget proposal to close recycling centres on Wednesdays and shorten opening times. The online consultation closes on 16th December.

Tree Wardens' Report c)

JF advised that the tree planting budget had been received from Broadland and £3,000 of trees have been ordered for planting. JF expressed his gratitude for the donation from Freethorpe Parish Council. AR advised that concerns about a rotten tree in Southwood will be notified to Cantley Parish Council.



AM advised that the forecast for the year is firming up. Income is around £2,000 higher than budget, thanks to two VAT claims falling in the year and extra income from Wickhampton Play Area. Expenditure is around £700 over budget, primarily due to the CiLCA training and insurance cost increase. The forecast contingency reserves are £9,709.59, which is within recommended guidelines. New Applications a)

> There were no objections to planning application 20221695 (50 The Green). Broadland District Council's approval of a reduction in affordable homes at the former garage site from 5 to 3 was noted. The need for affordable homes has been a crucial argument made by the Parish Council over developments. However it was appreciated that Broadland have balanced this reduction with conditions.

- d) Historic Buildings List - the latest list of Historic Buildings in the parish was noted, which now includes the War Memorial in the Methodist Cemetery (Grade II). JC queried the use of the name of "Dawdy's Farmhouse" for the Church Farm Cottages, Wickhampton.

10. Update on Ongoing Matters and Projects

a) Speed Management

The machine on the Green near the Manor House, facing Reedham, showed 85th percentile speeds of 31.6mph from 25,764 vehicles. The speeds have reduced by around 1mph. Volumes were down from the summer. Approximately one-fifth of drivers broke the speed limit, which is 30mph. PLEASE DRIVE SAFELY. On the Common, facing Great Yarmouth, 85th percentile speeds of 32.3mph from 24,292 vehicles. Volumes were up and speeds were down by 0.6mph. Just over one-fifth of drivers broke the speed limit. Parish Council was very grateful to Calica Computer Solutions for promptly fixing the problem on the Green when someone unhelpfully twisted the sign round during the night.

b) Play Area Inspections

Inspections continue as required. There were no new concerns to discuss.

c) Freethorpe Village Sign

Awaiting work to clean and re-paint.

d) Allotments

Awaiting AM to follow up with next-door residents at landowner's request.

e) Parish Nature Plan

No further progress with drafting.

f) Electronic Vehicle Charging Point

A quotation has been provided to AM and JC which is yet to be reviewed. JF and NS expressed reservations and it was agreed that more time and consideration will be nedded before taking this forward.

g) Wickhampton Pond

Norfolk Wildlife Trust have kindly assessed Wickhampton Pond and advised on steps to restore it. The first step is the removal of an invasive species, crassula helmsii, which has established itself where typha has been removed, is very easily transmitted and will overrun the pond if left. Work to be assessed and volunteers sought.
