- Minutes of the meeting held on Monday 19th June 2023 4. The minutes were agreed as an accurate record and were duly signed by NS.



Correspondence

- a) For decision (1) Town and Parish Council Forum is on Tuesday 1st August 2-3. (2) Resident concern about cutting of verges at Youngs Crescent was discussed, noting NCC's responsibility and policy. Parish Council does not have the capacity to maintain verges in the parish. (3) Bus shelter query – this has now been reduced to pavement adjustments.
- b) For information Parish Council noted (1) NALC update. (2) Acle Men's Shed open day (3) Broadland update (4) Freethorpe visit by Jerome Mayhew MP.

Planning

- a) New Applications 2023/1901 (7 The Green) was unanimously supported. There were no objections to the amendments to application 2023/0421 (12 Sutton Crescent). 2023/1905 (2 homes in place of the commercial building at 75 The Green): NS, PC, MB and DL were all concerned that only 3 out of 21 homes are affordable housing. PB was also concerned about overlooking of properties to the south. It was agreed that NS obtain further information from **ACTION NS** the planning department before responding.
- b) Decisions the partial approval of BA/2023/0231/TPOA was noted.
- c) Enforcements two unchanged open cases were noted. GN has asked the new Compliance Manager whether the reason each case is still open can be added to the report.

10. Update on Ongoing Matters and Projects

a) Speed Management - on Chapelfield, 85th percentile speeds were up from 32.5mph to 33.3mph on lower volumes of 14,831 vehicles. 1 in 3 people broke the speed limit, 176 vehicles exceeded 40mph. On the Green, near the shop, 85th percentile speeds were slightly up from 29.9 to 30.0 on increased volumes of 28,410 vehicles. 124 people exceeded 40mph. The speed machine is flashing up incorrect speeds near 106 the Common even when the flag is not flying. It doesn't appear to affect the accuracy of the speed recording.

b) Play Area Inspections - annual inspection reports were noted. No significant issues found

c) Parish Nature Plan - has been published on the website and is held with policies.

d) Electronic Vehicle Charging Point (EVCP) - is now with NCC.

e) Wickhampton Pond - the Parish Council confirmed the following points:

- (i) Application for registration of title to be drafted in early August. AM is authorised to sign this as long as satisfied that it is consistent with the Parish Council's understanding, and ask NpLaw to submit it to Land Registry. AM to share with Parish Councillors for information by email.
- (ii) Removal of crassula helmsii. Further professional advice has confirmed the need to wait for a year after clearance to ensure eradication. It was agreed that specialist pond contractors are needed to do this work. Estimates may be sought but may require grant funding.

(iii) Application for grants. It was agreed that registration is a pre-requisite.

(iv) Interim maintenance. It was agreed that great care is needed to prevent spread of the invasive weed. Restriction of cutting to just the highways verge was agreed. Either Highways or Norse to be asked to cut this, with full awareness of the presence of the invasive species.

(v) Involvement of MP. Should continue via AM with escalation to NS and GN if necessary.

- (vi) New WARNING sign. It was felt that this provided a partial mitigation. Further signage should be considered to warn of the invasive weed and to keep people away from the pond. Professional advice to be sought on the need for fencing it off.
- (vii)Financial compensation for water and maintenance carried out on a voluntary basis by local residents in the last 30 years. It was confirmed that compensation will not be considered.
- Building plot. It was confirmed that the Parish Council has no intention to use or sell the pond as a building plot.

(ix) It was confirmed that nothing will be done with the boundary without consultation with the neighbour. It is expected that Land Registry will confirm the boundary details.

(x) Plants and bushes at the Orchard. It was confirmed that there is no intention to affect these. If there is any possibility of this happening, the owner will be consulted before work commences.

- f) Rampant Horse PC advised that the Rampant Horse Preservation Society (RHPS) met last week, taking gauge of support for shares in a community-run pub. It agreed to form a CIC. A survey and valuation is needed. Permission has been obtained from the owner. Parish Council agreed to submit the drafted Pride in Place grant application, amended to £2,500.
- g) Picnic bench & tree in memory of Janet Church it was agreed that an almond tree as proposed by JF, and an octagonal bench be procured, along with plaques (IN MEMORY OF JANET CHURCH WITH THANKS FOR THE WORK SHE DID FOR FREETHORPE) subject **ACTION AM/JF** to agreement of David Grint and Richard Church.

11. Other Matters

- a) PB reported that he had met with two Highways engineers and explained the drainage issue at the Southwood entrance to the Common. Hopefully a solution can now be found.
- b) PB noted from the Police website that a camper van had been stolen in Freethorpe.
- Reports from Parish Councillors and items for next agenda None.
