# Minutes of Meeting of Freethorpe Parish Council Held at Freethorpe Village Hall on Monday, 19<sup>th</sup> April 2004 at 7.30p.m.

Present – Nick Spencer [presiding], David Lake, Janet Church, Linda Turner, Michael Blake, Paul Bacon, 19 Parishioners, Tree Warden [Joy Brock], Mike Northover [District Councillor] and the Clerk.

Apologies received from Brian Iles, Mark Askew and Andrew Garner.

**First ten minutes for public participation** - several residents at Chapelfield voiced objections to Kevin Frances' application for calf shed, implement store and hay loft on land adjoining 19, The Green, Freethorpe. Mike Northover said that he had spoken to Planning Officer and that no decision has yet been made, but that objectors, applicant and Parish Council representative are allowed to attend and speak for 3 minutes each at the meeting when decision will be made. A letter from the applicant had been sent to the clerk and to residents affected. Clerk was asked to write to B.D.C. stating that the P.C. position remains the same – i.e. concern about size of proposed building, but also stating that there are strong objections from nearby residents.

Stephen Smith gave an update on Freethorpe Football Club's activities – 1. setting up youth structures [working with the School etc.], 2. improving the ground [training area, floodlights etc.] and 3. Fund raisisng. It was agreed that the promised P.C. grant will be made at the May meeting.

- 1. Minutes had been circulated, and were signed as a true record.
- 2. Matters arising -dealt with under other headings.
- 3. Finance no financial transactions.
- 4. Planning Councillors supported application by Mr. R. Jermy for double garage at 103 The Green, Freethorpe, and application by Mr. T. Chillman for extension at 24, Youngs Crescent. The clerk was asked to query use of workshop etc. on application by Mr. D. Moore, 4 Chapelfield, Freethorpe.
- 5. A.O.B. The clerk had attended a Risk Assessment course on 14<sup>th</sup> April 2004, and will report to the Annual Parish Council Meeting about necessary changes to be put in place. The chairman reported that he has a new sign ready to place on the Playing Field.

The clerk reported that vandalism has occurred at the Cemetery at Freethorpe Methodist Church where gravestones have been knocked down. The Police have been informed.

Freda Pipes to be asked to give a report on Walpole Almshouse Charity at The Annual Parish Meeting when there will also be a report by the P.C.Chairman [Nick Spencer], and written reports by Mike Northover and Brian Iles who will be unable to attend.

The clerk gave a welcome and asked for nominations for Chairman for coming year. Proposed Janet Church, Seconded Linda Turner that Nick Spencer be re-elected. No other nominations and all were in favour of this appointment.

 Nick Spencer presiding asked for nominations for Vice-Chairman – Prop. Linda Turner, Sec. Michael Blake that David Lake be re-elected. All in favour. Appointment of clerk and responsible financial officer – prop. Nick Spencer, sec. David Lake that Edith Moll be re-elected at salary of £520.00 per annum plus expenses. All in favour.

Mrs. Gillian Brown to be asked to continue as internal auditor at salary of  $\pounds 20.00$  per annum.

- 3. .Matters arising two items with regard to planning -1. it was noted that the application by Kevin Francis for Calf shed etc. has been withdrawn. Tony Tibbenham thanked the Parish Council for their help in this matter.
  - B.D.C. had sent list of planning decisions which included application for 4, Chapelfield, Freethorpe [extension, car port etc.] which had been queried by the Parish Council, but this has received full approval from planners.
- FINANCE Cheques were authorized for Allianz Cornhill [insurance] £611.67, Clerk's salary £533.50 [expenses book checked by chairman], and Freethorpe Football Club's grant £1500.00
- PLANNING Applications by Mr. & Mrs. K. Colman for two storey Extension and double garage at The Old Vicarage, Lower Green, and By Mr. Kevin Grint for demolition of old buildings, extension to dwelling and double garage at 49, The Green, Freethorpe were supported by the P.C.
   A.O.B. Linda Turner raised the question of responsibility for cutting
  - walk ways at side of fields affected by the Countryside Stewardship Scheme. Clerk to make enquiries. A letter from Indira Goodson referred to overgrown verges making it dangerous for pedestrians especially where there are no footpaths e.g. Lower Green. Reference also made to danger at Callow Pit Corner, Southwood where visibility is very limited at present. Clerk to inform Highways of these matters, asking for priority treatment for Callow Pit Corner.

Linda Turner said that Parish Council are asked by Village Hall & Playing Field Committee to provide items and man stall at Village Fete on 27.6.04 Parish Pages and Norfolk Matters magazines were distributed. Appointed as Risk Assessment Councillors – Nick Spencer, David Lake.

Walpole Almshouse Charity report was presented by Freda 3. REPORTS Pipes who said that there has been a delay in installation of oil-fired central heating but that it is hoped that this will done in near future. Audited accounts to 31st March 2003 were available for inspection.

NORFOLK COUNTY COUNCIL - In the absence of Brian Iles, this was read by the Chairman and a copy is attached.

BROADLAND DISTRICT COUNCIL - Mike Northover's written report was read by the Chairman and a copy is attached. In his report, Mr. Northover stated that he will not be seeking reelection in June, and the clerk was asked to write a letter of thanks for all his valuable assistance while in office.

CHAIRMAN'S REPORT - Nick Spencer reflected on his first year as chairman of the Parish Council, and said that he feels that councillors are undervalued as their job can be very difficult at times especially with regard to decisions on planning etc. However, he is enjoying his term of office and is happy to have been reelected for another year. COMMUNITY POLICE OFFICE'S REPORT was given by Mark Askew who reported

that the crime figures for Freethorpe are very low. There had been two recent cases of burglary and also vandalism [especially distressing at Methodist Cemetery where grave= stones had been disturbed.] He gave a warning to householders about danger in hot weather of leaving windows and doors open, also to be aware of distraction burglaries and to be careful about allowing unauthorized persons to enter the home.

He said that speed monitoring will be undertaken during the summer months... A Police Dog Display at the Freethorpe C.P.School recently was very well received. His words about cuts in number of policemen to be on the beat sparked off protests, and it was decided to write from the meeting to Inspector Pestle at Acle and Chief Inspector Strong at North Walsham about concerns in this matter. 4.

Prop. D.Lake, Sec. N. Spencer that Linda Turner be re-elected to serve on the Village Hall and Playing Field Committee.

David Grint asked about whether money was available for P.C.grant to Football Club, and was told that this had already been authorized at the earlier meeting. Tony Tibbenham complained about placing of Dog Bin opposite Chapelfield bungalows and next to field where he says dog-owners run their dogs. Nick Spencer said that he would contact Mark Webster who hires the field in question and ask whether access could be made less easy. net 18 Allicos

#### Minutes of special Planning Meeting held at Freethorpe Village Hall on Monday, 7th June 2004 at 7.30.p.m.

Apology received from the Chairman of the Parish Council, Nick Spencer.

Present David Lake (presiding), Janet Church, Linda Turner, Michael Blake, Paul Bacon, Andrew Garner, 32 Parishioners and the clerk.

David Lake welcomed all those present, and explained that the meeting had been called to discuss the new application by Kevin Francis for an implement store and hay loft on land adjoining 19, The Green, Freethorpe. The Parish Council looked at the plans, and then these were made available for all to see. Discussion followed with a few residents from Chapelfield still objecting mainly on the grounds of loss of view over the fields, but many spoke in favour of the plan and when a vote was taken to judge present feeling 21 voted for, 5 against and 6 abstained. The Parish Council voted by secret ballot, 6 FOR, 1 AGAINST (the chairman

having two votes to make an odd number), so application was supported with a comment to BDC that the consensus of opinion at the meeting was in favour of the development.
