Matters arising: The clerk read reply from Charles Wharton Ltd. who 2. are not intending to take part in Countryside Stewardship Scheme at present. Wherry Housing have said that no vehicular access is now planned at 57, The Green. Position to be monitored by Parish Council. N.C.C. have refused to consider having a Zebra Crossing at Blacksmith's Shop Corner. Letter to be sent to Education Committee together with a copy of the N.C.C.letter, as it is felt that there is a hazard to school children at this junction which also serves outside school times for pedestrians going to the Village Hall and children going to the Play Area.

Further letter to be sent re damage to Sign post at Blacksmith's Shop Corner, also mentioning objection to some local sign-posts which

only give road names and not destinations.

PLÁNNINGS - Sub-committee had supported application by Mr. & Mrs. 3. Pegrim for extension at Cricketer's Walk. It was noted that the application by Mr. & Mrs. Stephens for alterations to the Manor House had been given listed buildings approval by BDC.

Finance - the clerk reported that she had received a cheque from NCC 4. for re-cycled paper (£90.30), and that the VAT repayment had been paid direct into P.C. Giro account (£24.85). Note to be made in Y.M. report that a total of £293.23 had been received by Parish Council for re-cycled materials during previous financial year. Copies of year's accounts to 31st March 2000 were presented to all councillors. Prop: D.Grint, Sec: R.Pipes that these be approved, all in favour. Roger to carry out internal audit within the next week, and prior to account being presented to District Auditor on 8.5.00.

- 3. Planning It was noted that Mr. & Mrs. Pegrim's application for an extension had been refused by B.D.C. Councillors supported application by Peter Fisher for dwelling at Old Chapel Road, Freethorpe.
- 4. Finance the clerk was authorized to pay insurance premium (£354.86) as soon as books are returned from District Auditor, as this is due on 1st June 2000.
- 5. A.O.B. Dennis Grint was appointed as Police contact for the Parish Council.

Minutes of Annual Parish Meeting held at Freethorpe Village Hall on Monday, 22nd May 2000 at 8.00p.m.

Present:- Roger Pipes (presiding) Dennis Grint, David Wright, Janet Church, Linda Turner, Michael Blake, David Lake (Parish Councillors), Mike Northover (District Councillor), Shaun Murphy (County Councillor), Freda Pipes (Chairman of Trustees for Walpole Almshouse Charity) and twelve parishioners & the clerk.

- 1. Minutes of previous meeting were read & signed as a true record.
- 2. There were no matters arising.
- 3. A report was given by Mrs. Freda Pipes, Chairman of Trustees for the Walpole Almshouse Charity. The accounts were made available for inspection, and the meeting were told that a B.D.C. grant had been received towards a £4000 programme of repairs, and that the cottages are now in good condition. The Trustees are currently looking at Alarm systems for the tenants, and in the future it is hoped to install showers.
- 4. Parish representative to the Playing Field Committee: Prop. Dennis Grint, Sec. Janet Church that Linda Turner continues. All in favour.
- 5. A.O.B. A number of residents from Youngs Crescent expressed concern at the service bus being routed via Youngs Crescent in order to pick up passengers near the Mace Shop, and it was also pointed out that people are now boarding the bus along the Crescent. It was felt that this is not suitable due to danger to children and also the narrow road. Shaun Murphy explained that the Parish Council had asked for a bus stop on the Common to help elderly residents who were not able to walk to Blacksmith's Shop Corner Bus Stop. He would speak to Planning & Transportation (N.C.C) and to the Bus owners suggesting that it might be possible for the bus to travel along Norwich Road, Limpenhoe Rd. & Old Chapel Road rather than Youngs Crescent. If this is not possible, then another meeting must decide next action. He would also mention speed of buses through the village.

- 1. Minutes were read & signed as a true record.
- 2. Matters arising: Letter had been received from N.C.C. in reply to request for a Zebra Crossing at the Blacksmith's Shop Corner. It seems very unlikely that N.C.C. would approve either a Zebra or a Pelican crossing, and they consider that it is more appropriate to have a School Crossing patrol (which post is being advertised at the present time). Clerk was asked to reply stating that we are conducting a survey of usage as the Parish Council feels that a Crossing is necessary at this point. (copy to Shaun Murphy). BUS ROUTE - Roger Pipes explained the position re buses using Youngs Crescent in order to pick up passengers at the Mace Shop, and he then asked Mr. Andrew Harding to address the meeting. Mr. Harding gave reasons why operator is not happy with alternative route via Old Chapel Road where bend near Fisher's is impossible to negotiate. Residents of Youngs Crescent said they were willing to take out the bank, and Mr. Harding said he would look into this possibility. David Wright then suggested route via The Common, Southwood and Porter's Road, and offered to take Mr. Harding to look at this and his offer was accepted. Lee Brister suggested that if this is not acceptable, it might be possible for a representative of the Parish Council to meet with the bus operator and a representative of N.C.C. to agree a route which is acceptable to all. Roger Pipes thanked Andrew Harding for coming, and said that he hoped for a positive outcome.
 - 3. Finance:- The District Auditor's report was outlined by the Chairman. The clerk arranged for the report together with a copy of expenses & payments summary to be placed at the Post Office for the next 14 days. Cheques were signed for clerk's salary and expenses £367.77, 3 Burial grounds @ £75.00 each, NCAPTC:£107.18, Norwich & Dis. Citizens' Advice Bureau £25.00.
 - 4. A.O.B. Various bookets & pamphlets were distributed.

 David Wright asked if the clerk would report that the one remaining post at the junction of Old Chapel Rd. and The Common had been dislodged.

Matters arising: Dennis Grint reported that the situation re lorries at the Garage has been resolved, he will inspect sign at the playing field, and also will again talk to Matthew Smith regarding the unfenced pond at The Green. Nothing further to report re A47 study. It was noted that a sign to Freethorpe has been placed on the A47 before the White House turning, but no signs have been placed on the Yarmouth side of Acle. Finance: Cheques were signed for CPRE (ann. sub) £17.50, Freethorpe Methodist Church Council £5.00 (hire of hall for meeting). The clerk reported that B.D.C. have paid the second instalment of the precept (£1500.00). It was not felt possible to make donations to WRVS or to Norwich Cathedral Appeal. As Village Hall roof repairs are under way, it was agreed that at next meeting the payment of £2,000.00 should be made to the Village Hall & Playing Committee.

A.O.B. The Shelroy Trust are again offering Christmas Hampers for needy families. Councillors to inform the clerk if they can nominate someone who would benefit from such a gift.

The clerk reported that N.C.C. will not be including The Common, Southwood Road or any of the road leading to the Beet Route in their winter programme of treating during icy & snowy conditions. P.C. were very disappointed, and asked the clerk to point out that these roads carry very heavy traffic, being the main route still used for Freethorpe people travelling to Norwich. These roads also carry sugar beet lorries, workers travelling to Cantley factory, school buses etc. Also it was noted that there are dangerous bends, and that the road from Southwood to Beighton is treacherous in wintry weather. ('Appeal for the council to reconsider this decision)

Mulbarton Parish Council had appealed for support in their bid to change the Police policy with regard to travellers. Agreed to write to Norfolk

Constabulary with a copy to Mulbarton Parish Council.

The Clerk had received details of work to be done in replacing Village Hall roof. Dennis Grint stated that he had strong objections to the colour which has been chosen by the Applied Constant and playing the state of the colour which has been chosen by the Annual General Meeting of the Village Hall and Playing

Norfolk County Council - letter re Bus Service - stated that all alternative routes have been rejected for vorious research to the Council must have been rejected for various reasons. Therefore the Parish Council must decide either to continue the parish Council must decide either to continue service as at present, using Youngs Crescent, or to revert to original route with pick-up at Blacksmith's Shop Corner and no service to those who live on The Corners. service to those who live on The Common .

It was decided to write to Andrew Harding of N.C.C. stating that the Parish Council are disappoint to Andrew Harding of N.C.C. stating that the Parish Council are disappointed at content of letter. They do not accept argument regarding lack of width of road for two large vehicles to pass etc. etc.
They also think it unfair to issue an ultimatum, so putting the P.C. under pressure, and would remind the N.C. that the request for a bus stop of pressure, and would remind the N.C.C. that the request for a bus stop on The Common did not ask for a route via Youngs Crescent. Parish Council objected to the plan on the grounds of: being out of character with surrounding area, health hazard, would spoil outlook for nearby cottages, likely interference to domestic appliances and devaluation of nearby properties.

The clerk had received a letter from B.D.C. re tree surgery being carried out on an oak tree at "Oaklands", The Green , Freethorpe (there is a preservation order relating to this tree).

FINANCE: a cheque for £15.50 was signed for R.B.Legion (Poppy Appeal) for poppy wreath which was placed on the Village War Memorial.

A.O.B.: N.C.C. had written re Bus Service that in New Year they would be reverting to former route -i.e. picking up at Blacksmith's Shop Corner with no stop on The Common, unless the Parish Council reached a decision to the contrary. - 1. Minutes were read & signed as a true record.
- 2. Matters arising: Despite attempts by Shaun Murphy, N.C.C. have decided that they cannot make an exception by including Southwood Road, The Common & Chapelfield in their winter programme of gritting. They have said that mud problems on Old Chapel Road will be dealt with in March. It was noted that Norfolk County Council used the meeting at Upton Parish Hall on 12th January 2001 to explain their policy re route hierarchy, but that no significant changes were promised.
- 3. Planning: Sub-committee had supported application by Peter Key to convert two barns at Grove Farm, Moulton St. Mary into dwellings with garaging, but had expressed concern about access due to speed of vehicles along Porter's

It was noted that the application for a monopole on Reedham Road had been refused due to it being detrimental to surrounding area. Application by Mr. & Mrs. K. Colman for alterations and extension at The Old Rectory, Wickhampton was supported, but it was felt that it is a pity to lose bay windows, and to use flat roofs on front elevation. Application by David & Pauline Wright for change of use of shop to residential was supported. (David wight left from while this application was being considered)

- 4. Finance: The clerk had prepared a financial report, and this was studied by Councillors. Proposed by Roger Pipes, Seconded by Michael Blake that precept for 2001 - 2 be set at £2,000.00. All agreed. Budget for the year was agreed (copy attached). Increases were proposed for donation to Village Hall by £100.00, to cemetery & church-yards by £75.00, and the clerk's salary by £130.00.
- 5. A.O.B. The clerk had received a plan from Richard Hirst re proposed paths with public access in connection with his Countryside Stewardship agreement with the Ministry of Agriculture. Copies of plan to be on display in the parish.

It was noted that Norfolk Constabulary are seeking to recruit more special constables, and poster has been displayed.

Parish Pages were distributed, and copy of Government White Paper re "Our countryside, a fair deal for rural communities" is to be circulated. David Wright said that he would speak to the School Bus driver who parks twice daily near the Blacksmith's Shop Corner to unload and load Cantley children who attend Freethorpe C.P.School.
