HELD AT FREETHORPE VILLAGE HALL -23RD APRIL 2001 -7.30.p.m.

Present: Roger Pipes, Dennis Grint, David Wright, Janet Church, Linda Turner, Michael Blake, David Lake, Mike North over [District councillor], four parishioners and the clerk.

The clerk welcomed those present, and invited the councillors to nominate a chairman for the coming year. Proposed D.Grint, Sec. M.Blake that Roger Pipes be re-elected - all in favour. The chairman then asked for nominations for Vice-chairman - proposed David Lake, sec. David Wright that Dennis Grint be re-elected - all in favour. Proposed by Dennis Grint, Sec. By Linda Turner that Edith Moll continues as responsible financial officer and as clerk for the coming year at a salary of £480.00 per annum plus expenses. All in favour. Internal auditor for coming year - proposed Janet Church, sec. Roger Pipes that Michael Blake be appointed. All in favour.

- 1. Minutes had been circulated, and these were signed as a true record.
- 2. Matters arising: Mike Northover to make enquiries at B.D.C. with regard to provision of dog bins. The clerk had spoken to Adrian Barber re village clean up, and the cub scouts are willing to undertake this work probably some time in May. Councillors had studied the Government White Paper which proposes sweeping changes for Parish Councils. Following comments to be made to B.D.C. with a copy of letter going to Keith Simpson [M.P. for Mid Norfolk]: councillors felt that the White Paper is geared to much larger councils, that training time for councillors and clerks would be excessive and result in less participation in work of Parish Councils by parishioners in full time employment thereby limiting the wide range of interests and expertise as represented on present Council. Councillors are against the grouping of parishes, feeling that this would result in a loss of local interest, and it is also felt that matters like transport would be difficult to deal with at Parish Council level, and are better left as at present.

N.C.C. had replied to letter re gulley at back Wickhampton road, and this is receiving attention.

- 3. FINANCE: the clerk presented copies of the accounts for the year ended 31st March 2001, and these were examined. Prop. D.GRINT, sec. M.BLAKE that these be approved. All in favour. It was noted that the insurance premium of £401.68 will become due while cheque book is at the auditors, and in between meetings. The clerk was authorized to pay this amount at the appropriate time.
- 4. Planning the clerk said that the sub-committee had seen plans for an extension of the entrance at Freethorpe C.P.School. She had also received an update re application by J.W.FISHER [MEATS] for 18 houses at site of abattoir. Mike Northover said that he would make enquiries at B.D.C. with regard to this, although it was noted that the Parish Council had supported original application with a proviso regarding the upkeep of green area at the site.
- 5.A.O.B. following to be reported to N.C.C. Highways Dept -flooding near No. 1 Council House, Low Road, Wick Hampton -photos as proof, flooding at Wickhampton end of Palmers Lane, need for clearing dirt and stones from road at the junction of Low Road & Church Road, Wickhampton. Also, clerk to report to Fire Service that three water hydrants have been vandalised -Chapel field & The Common. It was noted that Wickhampton Society are to erect a sign at the Bridleway near to Wickhampton Church. Dennis Grint asked that Village Hall & Playing Field Committee be made aware of new rules re Disabled toilets etc. Janet Church said that she would make sure that this is mentioned at the committee's next meeting.

Present: 7 Parish Councillors [Roger Pipes presiding], Mike Northover, four parishioners and the clerk.

- 1. Minutes of last Annual Parish Meeting were read and signed as a true record.
- 2. Matters arising: re Bus service it was eventually decided that the only solution to the problem was to continue using Youngs Crescent as this seemed the only way in which elderly parishioners living on the Common would be saved from walking down to the Blacksmith's Shop corner to catch buses into town.
- 3. A report on the work of the Walpole Almshouse Charity was presented by Mrs. Freda Pipes who stated that alarm systems had been provided for the tenants. Talks are under way with regard to the installation of showers. The accounts book was made available for perusal, also the audited accounts for the previous year.
- 4. In his chairman's report, Roger Pipes said that, as usual, roads, drains etc. had taken up most of the council's time during the past year, but they had also made a grant of £2,000 towards the new roof at the Village Hall, and had earmarked a sum of £500 for tree planting to mark the Millennium [this being in connection with the Countryside Scheme in which Hirst Farms are participating] He thanked Mike Northover, [district councillor] for his help and interest during the year, and also mentioned Shaun Murphy who had been our County Councillor, but who will be standing for another area at the June elections.
- 5. Representative to Village Hall & Playing Field Committee Prop. Janet Church, sec. By Michael Blake that Linda Turner be reelected. All in favour.
- 6. A.O.B. Andrew Dawson, a parishioner, said he had four matters to bring to the attention of the meeting. 1. Urgent need for roads to be re-surfaced pot-holes everywhere and uneven surfaces make things very difficult for cyclists, and make for water standing on roads, splashing from cars etc. 2. Dogs fouling foot-paths make for bad conditions for children walking to school and for pedestrians especially at night.
- 3. He complained about poor work done by council workers who trim banks etc.
- 4. He expressed concern about evidence that young people who frequent cycle shed at Freethorpe C.P.School in the evenings are leaving evidence of drug abuse, and he is concerned about effects on younger children at the school who may be drawn into the drugs scene. The chairman explained that the Parish Council has made several requests to the Highways Dept. re pot-holes etc., but have been told that a major road programme is still some time off because of shortage of money. The dogs fouling will be included again in Yarmouth Mercury report, the district councillor is looking into the possibility of provision of dog bins, and the clerk pointed out that little else can be done unless parishioners are prepared to name dog-owners who allow fouling to take place. State of footpaths will again be reported to Highways Dept, as will drainage problems. Hedge-cutting policy, said the chairman, is probably made to help preserve wild life. The clerk was asked to contact Terry Ogden [HEAD TEACHER] re problem at school, and report to next P.C.Meeting. Peggy Watson asked that flooding

At Palmers Lane [WICKHAMPTON END] be reported to the Highways Dept.

The clerk reported that the Cub Scouts had taken part in a Village Clean-up, and it was agreed that a donation be sent from next meeting [as books are at the Auditors]

3. <u>Finance</u> - the clerk reported that an internal audit had been carried out before the books had been taken to the District Auditor.

The following amounts had been paid into the Parish Council's Giro account by direct debit - £1,000.00 [first part of the precept], and £21.67 [VAT repayment]. It was noted that a cheque for Cornhill Insurance [£401.68] will be paid out as soon as the books are returned from the Auditors as this becomes due on 1st June 2001.

- 4. <u>Planning</u> sub-committee had supported an application for extension at Bumblebee Cottage, The Common, Freethorpe.
- 5. Any other business -the clerk had been advised of a change of licensee at the Rampant Horse Public House from R.J.Alexander to David & Jacqueline Crowe. B.D.C. had asked whether the Parish Council would like to change back to them for servicing Paper Bank, but it was decided to keep with N.C.C. as at present. Mr. Fielding, parishioner, spoke about vehicles exceeding speed limit, especially between 7.30. and 8.30a.m. and 5.30. and 6.30.p.m.- clerk to report to Norfolk Constabulary, and suggest need for monitoring speed of vehicles.

Cheques were signed for burial grounds funds at All Saints Church, Freethorpe, St. Andrew's Church, Wickhampton and Freethorpe Methodist Church @ £150.00 each, the clerk's salary £480.00 plus expenses of £14.47, Cub Scouts £20.00 and NCAPTC £114.60. The clerk was authorised to transfer £300.00 from the deposit to the current account with GIRO.

5. A.O.B. -Dennis Grint to be asked to look at seat near Village Pump as some repairs are needed. Highways Dept. to be informed about three drains on Old Chapel Road which are blocked by mud. Wickhampton Society secretary, Betty Lacey, had written to ask for help with regard to cleaning out the Village Pond, and the clerk was asked to enquire about the possibility of grant aid etc. The chairman had received complaints from parishioners about the traffic hazard caused by parking of large vehicles at the Garage, and the clerk was asked to write to David and Kevin Grint about this problem. - A.O.B. Each councillor was given copy of booklet on New Code of Conduct 4. for Parish Councillors. The Chairman explained that a Register of Interests will be kept by the clerk with a copy at Broadland District Council offices. It is hoped that as many councillors as possible will attend the meeting at Acle Recreation Centre on 21st February 2002 -7.30.p.m. which will deal with this subject. Parish councillors will be asked to sign new code of conduct at April meeting, and new legislation will be officially adopted at the Annual Meeting in May.

Mr. Dennis Grint left the meeting at this point as parishioners wished to raise a matter concerning his family business.

Mr. McMartin spoke on behalf of parishioners who are concerned about the parking of large vehicles at Aitchison's Garage, causing obstruction to the highway and damage to grass verges creating a real danger to children and other pedestrians crossing or walking along The Green. Environmental issues were also mentioned - i.e. suspected rat infestation at rear of property, noise nuisance and spillage of fuel causing a fire hazard. The clerk was asked to write to Grint Drylinings [Freethorpe] Ltd. asking for action to improve the situation.

P.C. voted unanimously for Elsie Grimson to be Parish Council member of the Broadland District Standards Committee.

Clerk was asked to report to Highways Dept. -damage to road sign at Old Chapel Road and to sign-post at crossing of Palmer's Lane, Church Road Wickhampton and Mill Road. Pot holes need urgent attention near Lower Green Farmhouse, Low Road, Wickhampton [near Council Houses], and at junction of Old Chapel Road and The Common, Freethorpe.

It was noted that Wickhampton Society have received two quotes for Pond clearance - £2,500 and £2,600 - more prices to be sought with hopes for a much lower amount.

Various leaflets etc. were distributed.
