Norfolk education transport officer had offered to change bus stop from outside the Rampant Horse to near Telephone Kiosk (mornings only) so that Acle High School children do not cross road to board bus. P.C. agreed to this change. Letter to Acle High School re hazard at Old chapel road where scholars wait on the highway near the road junction.
